Message from the Executive Board:

Dear Delegates,

Welcome to the Review Meeting of United Nations Women at MCGSMUN 2017!

"At the 2005 World Summit, leaders declared that "progress for women is progress for all". They agreed that gender equality and human rights are essential to advancing development, as well as peace and security. Countries leading the way forward were instituting free secondary education, subsidies for girls and incentives for households." They are also investing heavily in building access nodes for media and information and communication technologies. Various UN Committees are committed to promoting universal education that includes life skills, equality and human rights, especially the right to sexual and reproductive health. "At least 2 million young women and girls in developing countries are affected by obstetric fistula -- a condition that had been eliminated in wealthy countries more than a century ago. But while goals and commitments are in place, we still have far to go in ensuring their full implementation -- from primary-school enrolment and maternal mortality rates to women's economic independence and representation in decision-making positions". Despite consistent efforts, the conditions in rural areas remain stagnant and difficult as far as education, health and employment are concerned. Therefore, we have gathered to discuss the following themes.

Priority Theme for Discussion: Challenges and Opportunities in Achieving Empowerment of Rural Women and Girls.

Secondary Theme for Discussion: Participation in and access of women to the media, and information and communication technologies.

Review Meetings are dedicated to sincere impact measurement of the work previously done. The insights developed on our current on-ground projects must be articulated based on three key process-insights: **Observation, Challenges and Way Forward.**
